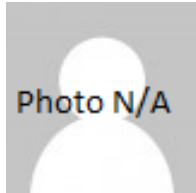

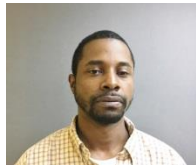
Felony Arrests

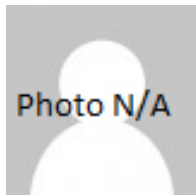

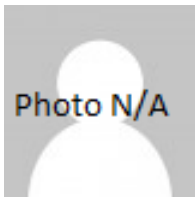

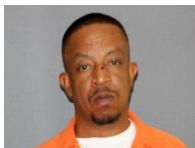
