

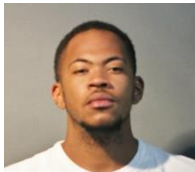

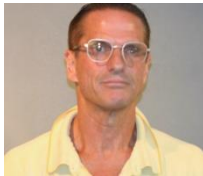
### Felony Arrests
